Policies Acknowledgement and Service Use Agreement For Catalyst Soccer Clinic Training Participants

Scheduling Regulations

It is mandatory for all schedule management by both the trainer and client to be conducted through the digital appointment system provided by Catalyst Soccer. Trainers list their public availability online for 4 weeks in advance. The online appointment system has a 1 hour block for making changes to the trainer/player's clinic schedule. To change an appointment that is more than 1 hour from its start time, view the confirmation email received when the appointment was first made, or login into the personal appointment account. Clients do not have the ability to cancel appointments on their own, they can only reschedule. If a client must cancel with less than 1 hour notice he/she needs to contact the trainer directly via email or phone to discuss rescheduling to a new date/time. Each trainer has their own specific policy for solving late cancellation issues so it is best to keep open communication with him/her. Catalyst Soccer is not responsible for resolving disputes of scheduling conflicts, but administrators are available to assist with technical difficulties using the appointment system.

Payment Regulations

A \$5 reservation fee is required to be paid prior to confirming an appointment online. This should be paid by the client, but if a trainer reserves a clinic on behalf of the client then the trainer must pay the \$5 reservation fee with their own card. However, the trainer may elect to recover that charge by informing the client that an additional \$5 will be owed when they meet for the clinic. If clinic participation is rescheduled to a new date/time, either by the trainer or client, the original \$5 appointment fee will be applied to the new date/time. If it is canceled and not rescheduled to a new date/time then the trainer will note the "Canceled" status in the appointment system and Catalyst Soccer administrators will refund the \$5 fee. However, the \$5 booking fee is not refunded for "Late Cancel" and "No Show" statuses or due to a client's dissatisfaction with the trainer or lesson. If a client is displeased with the quality of the training session and wants a refund of the trainer's clinic fee then he/she must communicate directly with the trainer about his/her concerns. Catalyst Soccer is not responsible for resolving disputes of financial compensation to the trainer.

Proper Conduct

All participants, spectators, and trainers are expected to maintain a high level of positivity, maturity, respect, and sportsmanship before, during, and after clinics. Most services are conducted in public areas so a good attitude is important to display at all times. If anyone's character is deemed inappropriate or unethical then the parties involved may elect to suspend or terminate the service at their own will. If a trainer wants to use the image of a player for social media / promotional purposes he/she must first receive consent from the player (or parent/guardian if the player is a minor) before posting the image publicly. Catalyst Soccer is not responsible for resolving disputes of conduct or quality performance, but clients are encouraged to rate trainers in the appointment system and email Info@CatalystSoccerTraining.com with testimonials of good or poor service by a specific trainer.
